General update – Covid-19, Face coverings and rotas, Clinically extremely vulnerable pupils, Year 11 revision microsite and resources, Sixth Form Virtual Open Week, Examinations – Plan B

National lockdown 2 has begun. A phrase I hoped not to have to write after the summer. However, we have gone about our business in a sensible and methodical manner this week. It hasn't been without its challenges but I feel a sense of pride in seeing the teamwork, camaraderie and high levels of professionalism from my staff team.

Whilst the roads have been a bit quieter on the journey in and out of North Hykeham, it feels like business as usual for us and so it should be. I hope it remains that way and we can carry on doing what we do best.

Covid-19

As I write, the infection rate in North Kesteven has risen yet again, as has the national average. When I last wrote to you, there were 132 cases per 100,000 people. It now stands at 192 cases. The national average is 156. The infection rate in Lincoln has dropped a little. This now stands at 239 cases per 100,000. The last time I wrote it stood at 280. This is a small glimmer of encouragement in the hope that lockdown seriously dampens the spread.

You may be aware that the national guidance for schools was updated this week to reflect our expected response to lockdown. Interestingly, we received it late on Wednesday, giving us limited time to make any necessary changes. As it turns out, we were already implementing the recommendations anyway so limited change has been needed.

Face coverings and rotas

Face coverings will be mandatory in communal areas of secondary schools. They will still not be recommended in classrooms. I allowed myself a wry smile when I read this. As you will be well aware, we have been doing this since September. The only difference now is that it is a national expectation. This vindicates our vigilant and proactive position in my view and allows us some satisfaction that our safety measures far outweigh those in most schools up and down the country.

Face coverings will be mandatory for pupils in Year 7 and over on dedicated school transport. This has been the case for some time but without youngsters being challenged. When I am on duty at the end of the day I always try to check the buses as they leave and challenge anyone

not wearing a mask who belongs to SRPA. The hope is that we see the transport companies following suit now that they have the power to do so.

This is not mentioned in the guidance itself, but we understand from discussions with the DfE that no school will be formally asked to implement a rota system if staff isolations rise or there are numerous cases in a school. Informally, we've been told that the government "recognises that staffing issues may make it difficult for an individual school to remain fully open at all times, and that some compromises may need to be made." Given this, if we were to face challenges which meant I could not keep the Academy open to a specific year group or groups, I would discuss this with the Governing Body and let you know with instructions as to next steps. In short, once I have a plan, you will be the first to know. Let's hope it doesn't come to that and we can ride this out together.

Clinically extremely vulnerable pupils

Pupils who have been identified by their doctor as still considered clinically extremely vulnerable (CEV), will be advised not to come into school. The [government guidance](#) on shielding and CEV people has been updated to reflect this position. We will provide remote learning for any pupils in this category. You should receive a letter from the NHS if your child is CEV to share with us. It is helpful for us to have this information as soon as you have it so that we can work together to ensure we operate in the best way.

Pupils who live with people who are CEV, but are not CEV themselves, are still expected to come into school.

If any member of the family tests positive for Covid-19 or is awaiting a test result whilst displaying symptoms, please do not attempt to send your child to school regardless of this. We are duty bound to ensure the safety of the wider academy community and this would be creating unnecessary risk.

In addition, I was contacted by a parent today to inform me that her son in Year 7 had been stopped by the local PCSOs on the way home from school for being in a group outside larger than two. This is in response to the change in national guidance which states that 'you can meet one other person from outside your household in an outdoors public space.' This is a simple FYI in case the local constabulary are taking this approach. I will ensure that my staff teams are aware so that appropriate advice can be given in school.

Finally on Covid, whilst I will always help where I can, I cannot advise you on Covid matters that do not relate to the Academy. This week I have been asked to provide advice related to sports clubs in the community, whether someone's relative should book a test or not and to offer opinion about other unrelated medical matters which are affected by Covid. I would
