Well it is fair to say it has been an interesting week in education...

As we end the first week of the calendar year it feels like it has continued where 2020 ended but with more pace down the hill with the brakes off. I will try to make some sense of it all below:

Covid-19 and lateral flow testing

I am going to pause on updating you of the local infection rate for a while as the national lockdown has now come into force. However, needless to say, the situation makes for grim reading. We remain determined to keep our site manageable under the circumstances when we are stretched on many fronts. We have received some requests for keyworker attendance at the Academy which simply do not meet the government regulations. We will be keeping to these rigorously so that we can offer the best service to all of our stakeholders from students and staff to parents and governors.

As you may have seen via our social media channels, lateral flow testing has begun in earnest this week for staff and any students attending site. I know the media have lambasted the government for their approach to this (and quite rightly so) but, for now, we have made a positive start in this regard. I have taken the decision during the lockdown to train up a team of internal staff rather than to go for external agency workers. My team are very well trained and exceptionally able. In my view, trust and confidence is everything at this moment in time so we will continue in this manner until such time as we return to full and active school duties, when we will consider next steps.

We have also decided to call home, where we can, to let you know that a test has taken place and a negative result has been the outcome. Although this is not in the guidance and is actively discouraged by DfE due to the scale we will be working at, we think it is useful for now. However, we can only do that while the numbers of test subjects remain quite small so please don't be offended if we do this for a short while and it peters out. I will always keep you informed but my main overriding objective is safety and wellbeing for all.

Remote learning and live lessons

I remain determined to offer as normal a service as remote learning will allow including R2L time from 8.45am. This gives students a routine, a reason to get up and plough on and gives us sight of some fabulous youngsters each day. We all know how emotions can change from day to day for all of us, but especially children. This 'form appointment' allows students greater contact with us and is a step change from earlier remote offers.

All curriculum plans will be published in the usual manner by 9am on the Monday morning of that week. I encourage full attendance at Teams live or pre-recorded lessons wherever possible. I do encourage youngsters to behave in those sessions. My staff are working hard for you but not at the cost to the whole class. There have been some small issues this week which I am appraised of and parents have been contacted. Time to get heads down now, you know who you are.

We are seeing an increasing number of requests for paper copies of the work due to no access to the internet at home. This number has now topped 200. We cannot run a skeleton staff and offer a fifth of our main school paper copies of all work, it is simply unsustainable. If you have the internet at home, we will only be able to provide work electronically but we can look to support you with extra wifi and data services as DfE provide the details. I am in the process of receiving this and will be in touch with any families who wish to explore this as soon as possible.

EPlatform digital library

Students can continue to enjoy their learning by engaging with a broad spectrum of eBooks that will have something for everyone. Our eLibrary provides a resource to be used in lesson time too, particularly during KS3 reading lessons, enabling students to engage with a book of their choice. This continues to be a very exciting time for pupils at SRPA, despite the challenges we currently face. We welcome you to visit our eBook library with your child as you encourage the thrill of reading together, to help them explore the wonder of books.
