Covid-19 including use of face coverings, Medical data collection, The Big Ask, Attendance and punctuality, Transport issues, Sixth form induction

I hope that my weekly letter finds you well and looking forward to the planned relaxation of Covid restrictions from this coming Monday. With this in mind, we are making some small changes to our risk assessment, particularly around the use of face coverings as you will see below:

Covid-19 including use of face coverings

As I mentioned in my letter last week, I have been waiting for the latest operational guidance for schools to be published. As part of the government's move to Step 3 of the roadmap, from Monday 17 May, new advice applies to the use of face coverings by staff, pupils and students in schools in England. The national guidance has been updated to reflect these changes.

Face coverings will no longer be recommended for students in classrooms or communal areas. I am happy to bring this change in here and will review it again at half term. In addition, face coverings will also no longer be recommended for staff in classrooms but staff will be able to choose what they prefer to do. I will continue to recommend that face coverings should be worn by staff and visitors in situations outside of classrooms where social distancing is not possible (for example, when moving around in corridors and communal areas).

This week, your child should also receive their latest batch of home test kits. Public Health England and the DfE continue to strongly encourage staff and students to keep to the agreed testing regime of twice weekly tests. As a result, I encourage you to keep testing and reporting your findings through the NHS registration portal and, where necessary using our own MS Form document previously shared with you.

The Big Ask

Dame Rachel de Souza, Children's Commissioner for England has launched 'The Big Ask', the largest ever consultation with children in England. The survey runs until Wednesday 19 May and will ask children across England to set out their priorities for improving childhood post-Covid. The results of the survey will form the cornerstone of the Children's Commissioner's 'Childhood Commission' – an ambitious Beveridge-style report due to be published later this year.

The survey asks children and young people:

- what they think is important for their future success and happiness
- what if any concerns they have about their future
- whether they expect to have a better life than their parents, when they grow up
- what they think is holding children back from achieving what they want to when they grow up

Attendance and punctuality

We are currently experiencing more issues with lateness to school than we usually expect to see. Students in all year groups are expected to arrive at the Academy on time to start their day. We recognise that, on rare occasions, events occur which mean lateness is unavoidable. However, the attendance and safeguarding team will now be issuing sanctions for repeated lateness each week. Transport issues

Despite changes to our site which have now been independently inspected as safe for buses to use, the owner of Black Cat Travel still refuses to allow his buses on to our site for the dropping off and collection of students. While we will continue to make daily provision for our children to remain safe, this is far from ideal for all parties and is disappointing. This issue now lies in the hands of the County Council legal team as it is their contract and I have exhausted all avenues available to me to bring this to a conclusion.
