## Y6 Transition

I hope you have been keeping well and enjoying the summer months. The academic year is almost complete but we have the Y6 Transition Day to look forward to and the beginning of your child's journey with us.

As you'll be aware, Y6 transition day will take place on **Friday 3 September 2021**. To support your child throughout the day, we have split the transition day into a morning session and an afternoon session. Please see below to see which forms will be attending at which time of the day.

### **Friday 3 September morning session 8:30am – 11:30am.**

### **Friday 3 September afternoon session 12:00pm - 3:00pm.**

Your child should attend in their SRPA school uniform and it would be advisable that they attend with appropriate sun protection (cream, hat) where necessary. Your child may wish to bring a snack and a drink as there will be time for refreshments during their visit, they may also wear a face mask should they wish to. Finally, we would like to thank you in advance for ensuring your child is dropped off and collected at the appropriate times. When you arrive on site at our Academy, you will see staff wearing red jackets who will be happy to direct you and support you where necessary.

When you enter the Academy site to drop off and collect, do not go through the green ANPR gates. Instead, please park cars and collect your child from the overflow car park to your left as you approach the green gates. Staff will direct you on the day.

It is important to drop your child off at the arrival time because when they arrive we will be asking students to participate in a lateral flow test (LFT) for COVID. This will help us to ensure the whole group is kept safe and follows the current guidance in place for secondary schools. We will be doing this for all year groups as they arrive back to school in September so it is important we include the new Year 7 cohort in this too. We will do the LFT as soon as students arrive so once again, please ensure your child is dropped off at the arrival times stated above.
